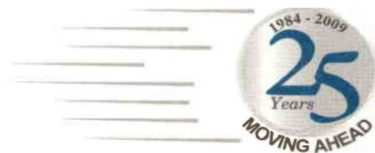



There was an error in reporting the date of appointment of some of the Directors in the Corporate Governance Report submitted under Regulation 27(2) of the LODR Regulations in September 2020 and December 2020 quarter. The said error was corrected in the report filed for the March 2021 quarter.

Due to delayed receipt of the signed audit report from the auditors on account of lockdown and the auditor and his team working from different locations, the intimation of the results for the FY ended 31-03-2020 was delayed by about 30 minutes; it has been explained by the Company that the delay was beyond their control.


