**Sub: Disclosure pursuant to Reg. 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to the provisions of Regulation 30 read with Part A of Schedule III of SEBI (LODR) Regulations 2015 and further to our disclosure dated July 31, 2023, we write this to inform you that the Company is in receipt of a demand from Tamil Nadu Pollution Control Board (TNPCB) on 18<sup>th</sup> March 2024 to pay a sum of ₹ 1.02 Crore towards the Environmental Compensation in connection with the exceedance of emission parameters alleged to be committed during the period from April 2019 to December 2020. As per the NGT Order dated July 2023, the said fund would be utilized by TNPCB for the conversion of the existing roads in the Manali Industrial areas into concrete roads to minimize the dust emissions from the vehicular population.

There is no impact on the operation and other activities of the Company, except to the extent of financial implication which is limited to a sum of ₹ 1.02 Crore.

The Company has taken up this matter with TNPCB and requested for re-consideration of the said demand.

We further wish to inform that the Company is in adherence to the prescribed environmental conditions and will continue to adhere the same and comply with law.

We request you to take the above information on records.
