Tamilnadu Petroproducts posts revenue of ₹ 1489 Crores for FY2025-26 & ₹ 126 Crores in Q4 of FY2025-26

19th May 2026, Chennai / Mumbai: Tamilnadu Petroproducts Limited (TPL), Chennai based Petrochemical manufacturing company, announced its Audited Financial Results for the Fourth Quarter FY26 and for the Year ended FY 2025-26 today.

Financials:

During FY2025-26, The Company earned ₹ 1489 crore in revenue as compared to ₹ 1846 crore during FY2024-25. Net profits registered at ₹ 88.76 crore as compared to ₹ 51.42 crore in FY2024-25.

During the last quarter of the year, with gross revenue of ₹ 126 crore, the operating profits were ₹ 20.31 crore, and net profits ₹ 5.83 crore.

The Company has incurred ₹ 0.59 crore during the year towards material damage and Plant restoration activities (Michaung cyclone – Dec'23) net of scrap sales. An amount of ₹ 7.62 crore receivables from the insurers has been disclosed as exceptional item.

“For TPL, the full-year financial performance reflects robust cost discipline and strong manufacturing efficiency. These efforts have enabled a higher bottom line despite a dip in revenue as compared to the previous year. During the last quarter, we faced considerable macroeconomic headwinds, particularly the sharp increase in raw material costs. It had an adverse effect on the quarterly results.

Looking ahead, despite ongoing geopolitical uncertainties, we remain focused on cost efficiency to improve our performance.”

LAB is used extensively in detergent production and also as solvent and binder in specialty products such as cable oil, ink, paint, insulations, etc. Caustic Soda finds wide applications in textile, pulp & paper, aluminium and soaps & detergents, etc. Chlorine finds use in vinyl chloride, chlorinated paraffin wax, pulp & paper, water purification, chlorinated solvents, etc. and Propylene Oxide is the feedstock for Polyols and other Petrochemicals production of which was commenced in 2018-19
